DEAR JUDGE KEITH WHITE,

YOUR HONOR, SIR, I COME BEFORE YOU NOW HUMBLY BECAUSE I DON'T KNOW WHERE ELSE TO TURN. I'VE BEEN TERRORIZED IN FEDERAL PRISON FOR WELL OVER 20 YEARS, ACTUALLY, CLOSER TO 24 YEARS. I'VE SUFFERED IN THE HARDEST AND MOST VIOLENT PENITENTIARIES IN AMERICA.

HERE AT THE ORANGE COUNTY JAIL SINCE MY ARREST ON OCT. 1, 2017 I'VE LOST 40 POUNDS OF WEIGHT. I'VE REQUESTED FROM THE MEDICAL DEPT. TO RECEIVE A HIGH CALORIE DIET. I'M BEING TOLD THAT THEY MUST GO BY A BODY MASS INDEX, THE SAME INDEX THAT DECLARES VIRTUALLY ALL AMERICANS AS OBESE. BECAUSE I'VE GONE ON A CAMPAIGN TO RECEIVE A HIGH CALORIE DIET, TODAY, I WAS TOLD BY MEDICAL DOCTOR THAT I HAVE HIGH CHOLESTEROL AND I WAS LEFT WITH THE FEELING THAT THE MEDICAL DEPT. CAN PUT ME ON A WORSE DIET, BEING A CHOLESTEROL FREE DIET TO EXACERBATE MY SITUATION EVEN MORE.

THE MEDICAL DEPT. DOCTOR TODAY EXPLAINED THAT I DONT KNOW WHY OTHER INMATES RECEIVE A HIGH CALORIE DIET. WELL, YOUR HONOR, I DO. BECAUSE BLACK INMATES ARE HIGHLY FAVORED OVER WHITE. I AM STARVING TO DEATH HERE WHILE OTHERS ARE WELL FED.

I'VE FULLY COOPERATED IN THE CASE NO: 17-015684 NOW BEFORE YOUR COURT. I'VE PROVIDED A FULL CONFESSION, GAVE UP UNSOLVED ARMED BANK ROBBERIES AND PROMISED TO DIVULGE 8 HOMICIDES. I'VE NEVER BEEN CAUGHT FOR THIS.

YOUR HONOR, I AM FACING THE PENALTY OF DEATH. MY WHOLE LIFE I'VE BEEN ABUSED. I'VE GOT NO MONEY, NO FAMILY, NO FRIENDS AND THE GOVERNMENT WANTS ME DEAD. I SUFFER FROM MENTAL ILLNESS.

I AM STARVING TO DEATH AND MY INSANE DEFENSE TEAM WANTS ME TO WAIVE MY RIGHT TO A FAST AND SPEEDY TRIAL.

SINCE MY ARREST ON OCT. 1, '17 I'VE LOST 40 POUNDS OF BODY WEIGHT, BECAUSE I DON'T GET ENOUGH FOOD. THE MEDICAL DEPT. HERE SAID: "WE'LL MAYBE YOU'LL STABILIZE". I'M ASKING TO BE FED MORE FOOD. PLEASE! MY DEFENSE TEAM IS MORE CONCERNED WITH PERHAPS HOW THEY WILL LOOK AT TRIAL THAN WHAT IS BEST FOR ME.

YOUR HONOR, IT IS A SAD DAY IN AMERICA WHEN I, THE DEFENDANT WILL BE THE ONLY ONE TELLING THE TRUTH AT TRIAL.

I WANT TO TESTIFY ON MY OWN BEHALF AT TRIAL


I WANT TO SPEAK ON MY OWN BEHALF AT THE PENALTY PHASE.

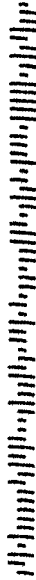
