On December 20, 2018, I responded to [REDACTED] in reference to a missing adult who is depressed and demonstrating suicidal feelings. Upon my arrival I met with the reportees, Cody Amato and Margaret Amato. They are the brother and mother of the missing person, Grant Amato. According to them, Grant recently lost his job as a nurse and failed out of graduate school. He has been having strong feelings of worthlessness and what they have observed as severe depression. Grant has not been medically diagnosed as of this date. The family did go together to a mental health counselor recently and said that Grant broke down emotionally and admitted to being severely depressed.

Yesterday, Grant left the home without saying anything to anyone. His mother observed him drive off the property. A short while later she had a text conversation with him in which he told her that he was really tired of dealing with everything and he is just going to handle it his own way. Both Mrs. Amato and Cody say this is so out of character for Grant and that they are 100% convinced he will try to harm himself. Grant has access to firearms and owns firearms. They are not sure if he has taken any of his from the house as they aren't sure of his inventory. Mrs. Amato did remove one from his vehicle prior to leaving town, however when she returned home two days ago Grant told her that he knows she took one out of his car but she doesn't know that he has another in the car.

Cody Amato has been able to monitor Grant's SunPass account. The last known point of SunPass activity was yesterday afternoon exiting SR 528 near I-Drive. Grant has an iPhone and Cody has been in touch with Apple to see if he can get access to Grant's account or take over control of the account so that he can use the find my iPhone application. Grant's phone carrier is Verizon.

Grant was entered into FCIC/NCIC as missing under endangered " status. There is reasonable concern for his safety and mental health at this time.

On December 21, 2018, I received a phone call from the SCSO teletype operator. She advised that Grant was located in Apopka at his grandmother's house by Apopka Police. I was put in touch with Officer Remillard with the Apopka Police Department. He said that he responded to a suspicious car near [REDACTED]. When he ran the tag he received the missing person alert for Grant. He was able to make contact with Grant at [REDACTED], and made an evaluation of him that did NOT indicate a need for psychiatric evaluation. Grant told him that he just needed a break from his mother and that he had no intention of hurting himself.

Based on Officer Remillard's observations of and discussion with Grant there no longer appears to be a concern for his safety. Grant was removed from FCIC/NCIC as missing. This report has been inactivated.
