Legislative Leaders,

We are writing today to urge you to impanel a bipartisan commission to audit, investigate and remedy the Executive Chamber's hiring practices, security protocols and administrative procedures following the unsealing of the Eastern District of New York's indictment detailing their charges against Linda Sun, Gov. Hochul's former Deputy Chief of Staff. As you know, the federal government's exhaustive, credible charges paint a shocking picture of foreign espionage, corruption, and catastrophic security failure.

Last week, it was unthinkable that a Chinese Communist Party agent could infiltrate the highest levels of our state government. Now, it's reality. Together, we can either choose to live up to our oaths of office and treat this national security breach with the seriousness it requires or we can sit on the sidelines and hope that the same protocols we just watched fail on the world stage magically start to work.

There is no indication that the governor accepts the gravity of this situation nor the need for sweeping action. We certainly have not heard her detail any plans for an audit by the state's Division of Homeland Security and Emergency Services. We haven't heard her announce an investigation by any trusted independent entity, and we haven't heard her seek help from the federal government. The administration's inaction makes the Legislature's co-equal role in our state's security and well-being even more prominent. Our solutions-oriented commission should be prepared to:


- Identify and solve the deficiencies in the executive's hiring process that would allow a Chinese Communist Party spy to infiltrate the highest levels of New York State government.
- Audit the state's national security protocols and their resiliency to foreign interference.


- Analyze the chain-of-command processes that allowed the governor's signature to be affixed to official documents by a foreign agent without appropriate authorization.
- Investigate why it took so many years and a federal investigation for the accused's flagrant, illegal behavior to attract the notice of any internal watchdogs or flag any security mechanisms.

It is our recommendation that each of you co-chair this commission to dispel the question of political motivation and to draw on the broad, diverse capabilities across the legislature's full membership. The commission should collaborate with outside experts, including national and cybersecurity professionals, federal law enforcement and intelligence officials, leaders in human resources, and other appropriate personnel. It must possess subpoena power.


We look forward to hearing back from you on this urgent matter of national security.


