Every year, NYSOFA invites New York's 59 county Offices for the Aging and their partners to nominate older adults who have made incredible contributions in their community through civic engagement and volunteerism. It is my distinct privilege to honor this year's nominees for Older New Yorkers' Day 2023.

New York State truly values the contributions made by these nominees and the countless other volunteers across the state that make New York a great place to live for all ages. Each year in the state, nearly 1 million volunteers age 60 and over contribute 495 million hours of community service at an economic value of \$13.8 billion. 2023 GOVERNOR'S EXEMPLARY SERVICE AWARD

AWARDEE: Russell E. Diethrick, Jr. Chautauqua County



Russell E. Diethrick, Jr. is a steadfast community leader who has served dozens of organizations in a leadership style marked by quiet strength. Diethrick's dedication to any cause is exemplified by his consistent presence and thoughtful participation, always respectful of differing viewpoints. He embodies the essence of a true gentleman and is sought after as a revered influencer within the community. His accolades extend to both his professional achievements and his significant volunteer contributions, with the local professional baseball stadium proudly bearing his name.

Diethrick has especially played an important leadership role in many groups that support older adults, including the United Senior Council, representing all local senior clubs. He was a founding member of his community's Office for Aging advisory board in 1973, offering his guidance during his remarkable 50-year tenure on the board, often assisting in the search for new leadership.

A graduate of Jamestown High School, class of 1952, Diethrick is married to June Christensen and maintains close ties with his sister, brother-in-law, nieces, and nephews. His service extends beyond the community, as he served in the U.S. Army Reserves from 1957 to 1963. Professionally, Diethrick worked at Marlin Rockwell Corporation from 1952 to 1964 before joining the City of Jamestown in 1958. He began as an Assistant Recreation Director and eventually ascended to the position of Director of Parks, Recreation, and Conservation in 1972. In 1991, he transitioned to Director of Development for Babe Ruth League, Inc. until 1993, followed by his role as Community Development Officer for Jamestown Savings Bank until 2015.

Diethrick's dedication to his community extends to the realm of radio, where he collaborates on several talk shows with Jim Roselle, Dennis Webster, and Andrew Hill. His lifelong mission revolves around making Jamestown and Chautauqua County exceptional places to live, work, and age gracefully.

"Humbly I would suggest there is no greater honor than building on the incredible foundation of generations past," he advises. "Use your God-given gifts of mind, body, and soul to inspire generations to come to add to this miraculous foundation."

The staff is very receptive to her quiet diplomatic way of getting to the bottom of residents' concerns. She works with the resident council to educate and empower them to speak up and make a change. She works tenaciously to help residents in her facilities. The seasoned residents will tell new residents: "If you have a problem, just turn to her she gets results."

Dejardin has lived in New York for the past 37 years, including 28 years as a professor of Art History at Hartwick College and as the Director of the Yager Museum for six years. She is a master gardener and volunteers to share her skills through Cornell Cooperative Extension. Roe is an extremely thoughtful volunteer, who considers all angles of the concerns that residents express to her, including collaboration with the regional office on relevant research of regulations. She has become adept at navigating her assigned facility, gaining knowledge of the culture of the facility and of key personnel. She supports a lively resident council, and she is forward thinking about the many challenges and aspects of providing care to long term care residents.

Roe takes every opportunity offered to further her knowledge by registering for webinars from different advocacy organizations and follows up with interesting questions and requests for further training in the areas she explores.

A native of Detroit, Michigan, Roe has lived with her husband in Troy, New York for over 40 years. She is retired from the New York State Archives where she was Director of Archives and Records Management.

"Volunteering provides interaction with people I might never have encountered otherwise and allows me to learn their stories," she says. "Connecting with their lives is enlightening, enriching, and just an important way to be a part of a community. As a volunteer, I've found that there is as much to be gained for me as to be given to others."





AWARDEE: Norma Chapman Albany County

Norma Chapman, a member of the Albany County Elder Committee, has shown a profound commitment to her community. Recognizing the unmet needs of older adults in Albany's West Hill, she took swift action, spearheading the transformation of the Chapman Center into a welcoming congregate meal site for West Hill older adults.

Chapman's community engagement has deep roots. She is a founding figure and advisor to the Frank Chapman Memorial Institute, a non-profit organization that has diligently delivered high-quality programming to inner-city youth from Arbor Hill, West Hill, the South End, and North Albany since 1995.

Under Chapman's guidance, the Institute has offered invaluable opportunities to countless young individuals. Through initiatives like the Institute's Summer Day Camp, conducted in collaboration with the City of Albany Summer Youth Employment program, hundreds of youngsters have gained valuable employment experience. The Institute has also provided a secure haven for children, offering after-school activities, mentorship, and a platform for creative expression through performing arts and fashion shows. Chapman's instrumental role has also seen the establishment of several other after-school programs, further enhancing the support available to the youth in her community.

Chapman generously volunteers for many organizations, including the African American Festival Day, Dr. Martin Luther King Jr. Observance March, Black and Puerto Rican Caucus Youth Talent Showcase, Equinox, Regional Food Bank, Ronald McDonald House, African American Coalition on AIDS, and the Board of Youth Bureau of Albany County.

"Volunteers do not necessarily have the time," she says. "They just have the heart."



AWARDEE: David Payton Albany County



David Payton, a lifelong New Yorker, has earned acclaim for his contributions to education and community service. In 2018, he was inducted into the New York State Middle-Level Education Hall of Fame. The following year, Payton received the prestigious Joan Lipsitz Lifetime Achievement Award from the National Forum.

Throughout his life, Payton has generously given his time and expertise to various organizations. From 1985 to 2018, he served on the New York State Middle School Association's Board of Directors. His dedication extended to the New York State Essential Elements Schools-to-Watch Recognition Program, where he played a pivotal role from 2004 to 2018. He also served on the National Forum's Fidelity and Membership Committees from 2012 to 2016.

In his community, Payton has been a force for positive change. Since 2000, he has actively contributed to the Williamsburg Neighborhood Beautification Committee, enhancing the quality of life for his neighbors. His civic engagement also includes involvement with the Guilderland Democratic Committee since 2006 and the Guilderland Board of Assessment Review since 2016.

AWARDEES: Dorothy & Melvin Dye Allegany County

Melvin and Dorothy Dye are community stalwarts, with extensive records of volunteer service. Mel Dye has served as a board member at North Park Wesleyan Church, Wesleyan Men's Director, a District Board of Administration member, and as a board member at Allegany County Youth for Christ. He also held the position of Secretary at the Agriculture Teachers of New York. Dot's volunteer roles include collecting for the Heart & Cancer Societies, involvement in the Western New York District of Wesleyan Church Ladies Ministries, and contributions to Allegany Hope.

Currently, they continue their volunteer work with the North Park Wesleyan Church landscaping committee. Dot plays an active role in the church's welcoming, visitation, and card committees.

Their volunteerism extends to Meals on Wheels, where they've dedicated over half a century. Dot, with over 27 years of service, and Mel, with 25 years, have not only provided nutritious meals but also warm companionship to those they serve.

Limbaugh's roots trace back to Brooklyn, where she was raised by her grandmother. A passionate Yankees fan, Limbaugh's life has been touched by the challenges of cancer, with her sister's untimely passing at 46 and her ongoing care for her own daughter who faces the same battle. In 1965, she married her late husband, sharing 40 years together until his passing in 2006. Cicero held various jobs until her retirement in 2011, after which she embraced volunteer work. At Bronx House, she initiated a ping-pong club and managed the flea market. In addition to her lunch program support, Cicero has catered meals for Bronx House after-school programs.

When it comes to volunteering, Cicero emphasizes patience, courtesy, and respect, as demonstrated in her belief that one should treat others as they wish to be treated. Her commitment to community service enriches the Bronx House Older Adult Center and leaves a lasting impact on her community.

His journey in volunteerism began in 1972 when he joined the Nimmonsburg Rotary. In his spare time, he visited nursing home residents and provided transportation for those in need. After retiring from the family business, Young's passion for helping others led him to the Broome County Office for Aging's home-delivered meals program, where he marks his twenty-seventh year of service.

Young has faithfully volunteered for the same home-delivered meals route, covering thousands of miles and delivering countless nutritious meals. His visits not only provide sustenance but also a friendly check on clients, brightening their day with a few minutes of conversation.

Beyond his own service, Young instilled the values of volunteering and community service in his children, even recruiting one of his daughters to join him on his meal route. Today, she serves as the driver while Young takes on the role of the friendly visitor, creating meaningful connections with the program's participants. Young cherishes the opportunity to meet diverse individuals, both fellow volunteers and clients, whom he now considers good friends.

Born in 1929, Young's formative years were spent in Maine, a place that holds a special place in his heart. After earning an engineering degree from a Maine college, Young married his wife, Barbara, in 1959. In 1969, when he faced a layoff from Sperry Link in Long Island, his ambition led him to establish a Taylor Rental franchise in the Binghamton area. Alongside his wife and three children – Emily, David, and Nancy – he embarked on a new chapter in the community he grew to love.





AWARDEE: Janet Stiger Cattaraugus County

Janet Stiger brings an infectious spirit and dedication to her daily work. Her consistent dedication and tireless work ethic are nothing short of remarkable, even in "retirement."

Stiger is a force of nature, tackling tasks with a level of industriousness that leaves others in awe, say her nominators. Her mission is simple: to spread cheer, share amusing anecdotes, and offer valuable advice to all who cross her path. Stiger's capability, friendliness, and hidden treasure of inspiration make her an invaluable asset to those fortunate enough to know her.

Born in Sayre, Pennsylvania, in July 1948, Stiger grew up as a middle child with a twin sister, surrounded by five sisters and one brother. In 1993, she relocated to Olean to pursue her education at the Olean Business Institute and Elmira Business Institute. Her career journey began as a paralegal, where she excelled in statistics and clerical duties. However, her true passion involved advocating for clients, a passion that eventually led her to a fulfilling career with the non-profit organization Directions in Independent Living. Here, she championed the cause of people with disabilities, empowering them to lead more independent lives.

Stiger's own life story is one of resilience and independence. She raised two daughters on her own and takes great joy in doting on her grandchildren, despite the geographical distance that now separates her from her family.

For Stiger, compassion, understanding, and unwavering devotion are the keys to making a significant difference. It's a philosophy that keeps her connected to people, deepens her appreciation for life's blessings, and fosters a profound sense of mutual appreciation in her interactions with others.



AWARDEE: Hazel Todd Cattaraugus County



Hazel Todd stands out as an exceptional volunteer, earning praise from her station manager as a true wonder. Come rain or shine, Todd takes on the most challenging home-delivered meal routes, despite numerous health concerns. Her cheerfulness and ever-present smile brighten the days of all she encounters.

In her nine years as a volunteer, Todd has become the beloved face of the county's nutrition program site, contributing to meal preparations with remarkable efficiency. She wraps silverware, sets up for lunch, and efficiently bags bread. More than her tasks, Todd embodies the role of a welcoming hostess, enlivening conversations on various topics and offering sage advice with her signature smile.

Todd's presence serves as an inspiration to her fellow center attendees. Her cherished tradition of saying grace over meals blesses her friends with her spirit, love, and dedication.

Born in London, England, during WWII to an English mother and an Army father, Todd embarked on a journey to the U.S. at age two, where she met her father in New York. The family briefly resided in Cuba, New York, before settling in Olean, New York, Todd's childhood home. In 1963, she became a naturalized citizen and built a life with her husband, whom she lovingly cared for until his passing from cancer in the early 2000s. Together, they raised three children and welcomed grandchildren and great-grandchildren into their lives.

Todd's forty-year career as a school bus driver for Head Start, an early childhood development program, left a lasting impression on the children she served. Even after all this time, some still recognize her, a testament to her enduring impact.

For Todd, volunteering holds a special place in her heart. She believes it's a wonderful way to serve the community, extending a helping hand to those in need. Beyond that, it fosters a sense of community, providing social connections that enrich her life and keep her engaged with the world around her.



AWARDEE: Ron Jones Cayuga County





Ron Jones is a pillar of the Aurora Fire Department, exemplifying the spirit of volunteerism for an astounding 66 years. Serving as Assistant Chief, Jones' dedication to the department remains unwavering, even in the face of medical limitations that have reduced his active involvement. He continues to attend monthly meetings and drills.

Jones' journey within the department harks back to a time when only a select few had the privilege of wearing the limited number of simple rubber jackets available. In addition to his firefighting role, Jones was among the pioneers to enroll in one of the first EMT classes offered in Cayuga County, generously volunteering as an EMT for over 40 years. He became one of the county's first Critical Care Technicians.

One rescue mission over a local waterfall inspired Jones to seek safer methods for extracting individuals from gullies and ravines. In 1984, he played a pivotal role in founding the Cayuga County High Angle Rescue Team, a group that continues to provide crucial services today. His expertise in ropes and pulley systems earned him the role of editor for a book on rope rescue, authored by one of his original instructors.

A lifelong resident of Levannah, Jones dedicated his professional career to ironworking in Syracuse. He is a proud father of nine children, with a growing legacy of 51 grandchildren and several great-grandchildren. The current Aurora Fire Chief aptly describes Ron as "an all-around good guy."

Jones' philosophy on volunteering reflects his deep sense of community responsibility: "You volunteer to help your community, so someone is there to help on a person's worst day, and hopefully someone will be there to help you on your worst day."





AWARDEE: Lili MacCormick Cayuga County

Lili MacCormick has dedicated her life to many volunteer endeavors, leaving an indelible mark on her community. Her service includes council and board roles with the United Ministry of Aurora, where she's also been a Sunday School Teacher and gardener. MacCormick commits her time to the Auburn Correctional Facility Alternatives to Violence Project, regularly venturing within the facility's walls. She was an early supporter of the Auburn Homeless Shelter, which began in a church basement, now known as Chapel House, where she stocked shelves and distributed food at the King Ferry Food Pantry. Additionally, MacCormick lent her expertise as a volunteer tutor with the Emily Howland Elementary School reading program and served on the Aurora Village Board.

Additionally, MacCormick volunteered with the Cornell University Botanical Gardens and is an active member of the local garden club. Her personal 40' x 40' classical labyrinth, cultivated from cuttings taken from a single boxwood plant, is a spectacular display of her horticultural pursuits. Her meticulously maintained yard boasts an array of perennial flowers and plants. In 2016, her garden was a highlight on the Southern Cayuga Garden Club tour.

Born in Germany and raised in Brunswick, Maine, MacCormick graduated from Wellesley College and eventually settled in Aurora when her husband became a professor at Wells College in 1958. Together, they raised five children. She earned a master's degree in art history just two months before the birth of her fifth child, making her the sole recipient of such a degree awarded by Wells College. She subsequently served as an art teacher in the Southern Cayuga school district from 1973 to 1997.

At the age of 92, MacCormick cherishes her connections with children and grandchildren and revels in her active and fulfilling life. Her advice to others is simple yet profound: "Just get involved in things that interest you. There are always things to do."



AWARDEE: Russ Hyde Chemung County



Russ Hyde has dedicated over 50 years positively impacting youth and organizations dedicated to serving young people. His exceptional energy and enthusiasm set him apart in the world of community service.

During the pandemic, as the Board President of Cornell Cooperative Extension Chemung, Hyde displayed outstanding leadership, guiding the staff through challenging times with professionalism and dedication. His mentorship of youth in facing real-life obstacles mirrors his commitment to nurturing future generations.

For Hyde, community service is a way of life, not just a passing interest. His influence on youth, their caregivers, and the organizations supporting them is profound. Over the years, he has imparted invaluable life skills, contributed to organizational development, and offered unwavering support, encouragement, and wisdom to countless individuals. Hyde's impact on the community is immense and far-reaching.

Hailing from Elmira, New York, Hyde is a true New Yorker, deeply rooted in the city's rich history. As the only child of Elmira natives Agnes and Russell Hyde, his connections to the community run deep.

With 35 years as an educator in the Elmira City School District, Hyde's career encompassed diverse roles, including as a dedicated sixth-grade teacher and superintendent. However, his role as a special education teacher stands out.

"When engaging in volunteer work," he says, "I consider it of utmost importance to connect, educate, and mentor our youth. There exists a remarkable opportunity for volunteers to contribute to children's growth and well-being by assuming the role of mentors dedicated to their betterment."





AWARDEE: Ernestine Kyles Chemung County

Ernestine Kyles, a devoted member of the Cosmopolitan Women's Club for forty years, has made substantial contributions to the community by providing scholarships and organizing educational workshops for students in Chemung and Steuben Counties. During her tenure, she has held key leadership roles, including President and Secretary, and spearheaded various fundraisers to support the club's endeavors.

One of her most remarkable achievements is the establishment of the Ernestine Kyles Scholarship Awards, operating under the Cosmopolitan Women's Club. These scholarships specifically benefit African-American students in Chemung and Steuben Counties. Over the past twenty-five years, Kyles has awarded more than fifty scholarships, totaling over \$40,000. In 2022 alone, she granted scholarships worth \$500 each to five deserving students.

By empowering young African-American students through scholarships, she has played a pivotal role in fostering educational equity in the community.

In addition to her work with the Cosmopolitan Women's Club, Kyles currently serves as President of The ACME Benevolent Association, Inc. This organization hosts various community events, including the Black History Community Education Program, food and clothing drives, a Youth Easter Egg Hunt, and Repast gatherings for families.

Kyles, born and raised in Rayville, Louisiana, holds a bachelor's degree in elementary education from Southern University and a master's degree from Michigan State University. She taught at elementary schools in Saginaw, Michigan, and Cleveland, Ohio, before relocating to Horseheads, New York. Kyle and her husband, Roy, have one son and two grandchildren.

In 1976, she joined The Corning Museum of Glass, and after twenty-five years, Kyles retired, leaving behind a legacy of commitment and accomplishments.

Kyles' motivation for community service is simple, as she puts it: "I get pleasure from helping others. The smile on their faces, the rub from their hands, and the look in their eyes let me know how thankful they are that someone cares about them. That fills my heart with joy."





AWARDEE: Don LaFever Chenango County

Don LaFever has dedicated over 25 years to volunteering for Chenango County Office for the Aging, where his unwavering commitment shines. Rain or shine, LaFever delivers meals multiple times a week, brightening the days of every client he serves.

Most of LaFever's life has been spent in New York, born right on the family farm where his mother grew up. He briefly left the state during his three-year active duty in the Army, marking 27 years of military service. He remains actively engaged with the local American Legion, having served as a post commander and continuing as a board member.

In addition to his volunteering, LaFever has a strong presence in the community. For 35 years, he has delivered a Penny Saver route. An avid canoeist, he boasts 15 first-place titles in the Canoe Regatta, along with several second and third-place finishes. Despite being in his 80s, LaFever's vitality is apparent. He firmly believes in prioritizing health and fitness: "Without your health, you have nothing."

LaFever's philosophy is simple but profound: "If you enjoy helping others, there is no better way than to get out there and do it!" He recognizes the importance of caring for older adults, acknowledging that they once cared for us as children, and now it's our turn to reciprocate their care.



AWARDEE: Louis Thompson Clinton County



Louis "Buzz" Thompson embarked on his journey of helping veterans a decade ago at Post 1619, where he also became a member of the Sons of the American Legion, following in his father's footsteps as a World War II veteran.

For the past two years, Thompson has been a dedicated volunteer with the Vets Feeding Vets Program in Clinton County. In this capacity, he serves as an AmeriCorps Seniors volunteer for the Retired Senior Volunteer Program (RSVP) at St. Joseph's Community Outreach Center in Plattsburgh. Thompson's duties include delivering food and providing companionship to homebound and isolated veterans and widows of veterans. His commitment extends further as he assists veterans from outlying areas, accompanying them to their medical appointments at the Plattsburgh VA Clinic.



Notably, the 50/50 raffles held during Cruise Inn With Mike each week generates funds to support ICAN's annual Shop With A Cop event in collaboration with the City of Little Falls Police Department and the Little Falls Fire Department. Thanks to his generosity, children have the opportunity to shop for Christmas gifts alongside law enforcement officers, benefiting countless deserving families in the community.

During the holiday season, Bulger also provides hot meals to older adults who may otherwise spend the occasions alone, spreading cheer, companionship and extraordinary kindness.

His dedication to community knows no bounds, and he exemplifies hometown pride through many selfless acts.

A small-business owner, auto mechanic, and longtime employee of a local lumber yard, Bulger shares his life with a loving partner. Together they have two children and two grandchildren.



AWARDEE: Madeline Martinez Queens County







Originally from New Jersey, Sinclair moved to the Southern Tier with her family when she was 12, eventually settling in Owego, New York, in 1985, where she still resides today. Her career has been centered around helping others, starting in home health care and later working for Tioga Opportunities, Inc. for 14 years. In her roles, she provided valuable support to various programs, including Head Start and as a respite worker, aiding clients in maintaining their independence in their own homes.

Beyond her volunteer work and career, she is a creative individual who enjoys pencil drawing and crafting greeting cards for her loved ones. She can often be seen walking her canine companion, Junior, around Owego.

Her advice to fellow volunteers is simple but profound: "Find something you enjoy doing and be flexible."



AWARDEE: Sherry & Bill Alberta Tompkins County



In 1989, Sherry and Bill Alberta initiated the Elves Program with a heartfelt mission: to bring joy and assistance to children in need. What began as a gesture of kindness by purchasing gifts for a few children in a local elementary school has since grown into a transformative force, impacting the lives of up to 1,000 children annually through three distinct programs.

The Winter Holiday Program stands at the core of their efforts, spanning across forty schools in Tompkins County and its surrounding areas. Here, nurses and social workers identify children facing the greatest need, creating profiles shared with "elf leaders." These leaders then connect with individuals, families, or groups eager to sponsor a child, providing them with new clothing and toys during the holiday season.

In 2007, an "elf leader" expanded their impact further with the Summer Backpack Program. Now assisting a thousand children annually, this initiative equips each child with a new backpack filled with school supplies, ensuring they are prepared for the upcoming academic year.

The Albertas' third and newest program, the KozyKids Blanket Program, was inspired by a child's simple request for a warm blanket as a holiday gift. Each year, more than 250 new, cozy blankets find their way into local schools, offering comfort during the cold months.

Sherry and Bill Alberta's commitment to their community is a testament to their love for lthaca, New York, where they have resided for over four decades. Their dedication extends beyond their charitable work, as they cherish time with their family, explore the beauty of nature, and engage in various hobbies. Sherry is passionate about organic gardening and cooking, while Bill finds joy in stonework and playing the mandolin. Both hail from small upstate towns and share a profound dedication to helping economically disadvantaged children.







At 91 years old, Art Berkey stands as a testament to the enduring spirit of volunteerism. For more than 35 years during his retirement, he has dedicated countless hours each week to a wide range of activities aimed at supporting his community. He can often be found repairing homes and equipment, generously distributing refurbished tools, and welcoming young children into his garage and shop to impart the wisdom of craftsmanship and the virtue of patience.

Berkey's sense of duty extends to his neighbors, who frequently turn to him for rides. When approached, he consults his meticulously maintained calendar, juggling prior commitments such as the food pantry, blood drives, or committee meetings with a commitment to assist those in need. His dedication to community service is characterized by a profound sense of integrity, and he treats every individual with the respect they deserve.

Berkey's journey began on a 133-acre farm in Michigan, where he was born as one of six children. He embarked on an academic path, earning his bachelor's, master's degree in teaching, and Ph.D. from Michigan State University. His sense of duty led him to serve in the U.S. Army for 13 years, with a notable 16-month deployment during the Korean War. In 1967, he retired as a Captain. Following the war, he pursued a career as a high school agricultural science teacher and principal in Michigan. Over the next 28 years, he dedicated himself to teaching at Cornell University, retiring from the institution in 1995. He now resides in Ithaca, where he continues to make a profound impact.

AWARDEE: John M. Dowley, Sr. Ulster County



John M. Dowley, Sr. is a tech-savvy champion helping older adults by demystifying technology and bridging the digital divide. He has harnessed his expertise to empower older adults, teaching them to navigate the digital landscape with confidence and reconnect with loved ones.

Dowley's journey as a technology educator began with his pivotal role in designing the inaugural Senior Computer Learning Center (SCLC) at the Business Resource Center (BRC). His vision brought together instructors, equipment, and a modest budget, laying the foundation for a pivotal hub of learning. His tireless dedication has expanded this essential center to the Senior Hub, where he orchestrates regular classes and assembles a dedicated team of instructors. His personal instruction has equipped numerous older adults with the skills to utilize devices, access the internet, and embrace the digital era.

Beyond technology education, he is a committed advocate for various causes, from diabetes awareness to affirmative action and youth development. He annually participates in the American Diabetes Association Tour de Cure, diligently raising funds for crucial research.

A native New Yorker, he has spent most of his life in Ulster County alongside his wife Carol. Their family includes three children and six grandchildren. He retired from Sears Roebuck & Co. after a 30-year career in human resources, operations, and district systems management. In retirement, he transitioned into the role of a computer technology instructor with Albanybased MicroKnowledge, Inc., where he continues to make an impact with a focus on older adults.

During his tenure at Sears in Kingston, he served on the Board of Directors of the Resource Center for Accessible Living and the Ulster County Youth Bureau. AWARDEE: Gai Galitzine Ulster County

Since 2016, Gai Galitzine has been engaged in Kingston Seniors Serving in Place (SSIP), a self-support group dedicated to helping its members gracefully age in place. Her contributions include launching a monthly newsletter featuring member updates and valuable information for older adults. When the pandemic curtailed in-person meetings at the local diner, she organized a weekly Zoom gathering, enabling members to connect safely via devices or landlines. This initiative played a pivotal role in mitigating feelings of isolation among the SSIP community.

Her longest-standing commitment, dating back to 2013, revolves around the Circle of Friends for the Dying. She initially served on the board and later transitioned into an administrative role. Her responsibilities involved establishing and managing a comprehensive database of donors and contacts, orchestrating fundraisers, and providing invaluable support wherever needed. She was instrumental in the early stages of Jim and Lisa's Circle Home, a home for the dying located in Kingston.


